SOLICITORS, ICE CREAM VENDORS, TRANSIENT MERCHANTS LICENSE

APPLICATION SUBMITTAL

The following must be submitted, incomplete applications will not be accepted:

- Completed Application;
- Completed Background Screening Disclosure for each employee working in the Village;
- Color copy of a state issued photo ID for each employee working in the Village;
- Surety Bond in the amount of one thousand dollars (\$1,000.00);
- Food vendors must supply a certificate from the Lake County Health Department;
- If the applicant is a peddler, he or she must also obtain a certificate signed by a local physician that the employee(s) working in the village is/are in good health and free from any contagious diseases.

BACKGROUND SCREENING

Applicants must submit to a background check and fingerprinting. Complete and return the Background Screening Disclosure along with payment in the amount of forty-five dollars (\$45.00) for each applicant, to the Village Hall. Once payment is made, your application will be forwarded to the Police Department who will contact you to set up an appointment for your screening. The timeframe on the results is typically 4-6 weeks.

LICENSE FEES

DAILY: Ten dollars (\$10.00) per day the Peddler, Solicitor and Transient Merchant will be engaged in peddling or solicitation within the village; or

MONTHLY: Two hundred dollars (\$200.00) per month the Peddler, Solicitor and Transient Merchant will be engaged in peddling or solicitation within the village; or

ANNUAL FOR FOOD, BEVERAGE, ICE CREAM ONLY: One hundred dollars (\$100.00) annually for any Peddler, Solicitor and Transient Merchant who sells, offers for sale, or peddles any candy, ice cream, confection or other food or beverage for human consumption from any motor vehicle or other vehicle or cart of any kind, upon any public street or other public property.

LICENSE ISSUANCE

The Village will contact the applicant once the License is ready for issuance. The license fee must be paid at time of issuance.

LICENSE DISPLAY. Licensee shall at all times while doing business in this village keep in his or her possession the license provided for in section 5.40.090, and shall, upon the request of prospective customers, exhibit the license as evidence that he or she has complied with all requirements of this chapter.

Each solicitor or peddler shall at all times while doing business in this Village, keep in his or her possession the license provided and shall, upon the request of prospective customers, exhibit the license as evidence that he or she has complied with all requirements. _____

Each solicitor must honor all "no solicitor's signs" exhibited on residences or businesses. Any violations of will result in the immediate revocation of the solicitor's license. _____

PROHIBITED SOLICITATION PERIODS

- A. No Peddler, Solicitor and Transient Merchant may conduct the defined activities except between the hours of nine a.m. and nine p.m. on each day, and no solicitation or peddling shall be done on Sundays or legal holidays, unless authorized by subsection (B.) below. _____
- B. Peddlers, Solicitors and Transient Merchants who sell, offer for sale, or peddle any candy, ice cream, confection, or other food or beverage for human consumption from any motor vehicle or other vehicle or cart of any kind, upon any public street or other public property are permitted to conduct those activities between the hours of 9:00 a.m. to 7:30p.m. each day or sunset as defined by the National Weather Service, whichever occurs first, each day and on Sundays or legal holidays. _____

OBSTRUCTIONS OF PEDESTRIAN OR VEHICULAR TRAFFIC UNLAWFUL

No person, while engaged in any of the practices described in Section 5.40.020, shall block or obstruct the path of any pedestrian or vehicular traffic or block or obstruct any way of ingress or egress to roads, buildings, vehicles or other enclosures or conveyances. _____

VIOLATION – PENALTY

Any person violating the provisions of this chapter shall, be subject to a fine not exceeding seven hundred and fifty dollars (\$750.00). Each day that a violation continues shall constitute a separate offense. _____
